
**Subject:** Request for Approval to Conduct an “ Awareness Program on Poison Prevention”.

- **College Students:** Approximately 24 students from various departments attended the program.


### Beneficiaries:

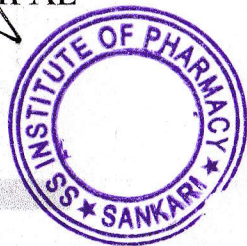

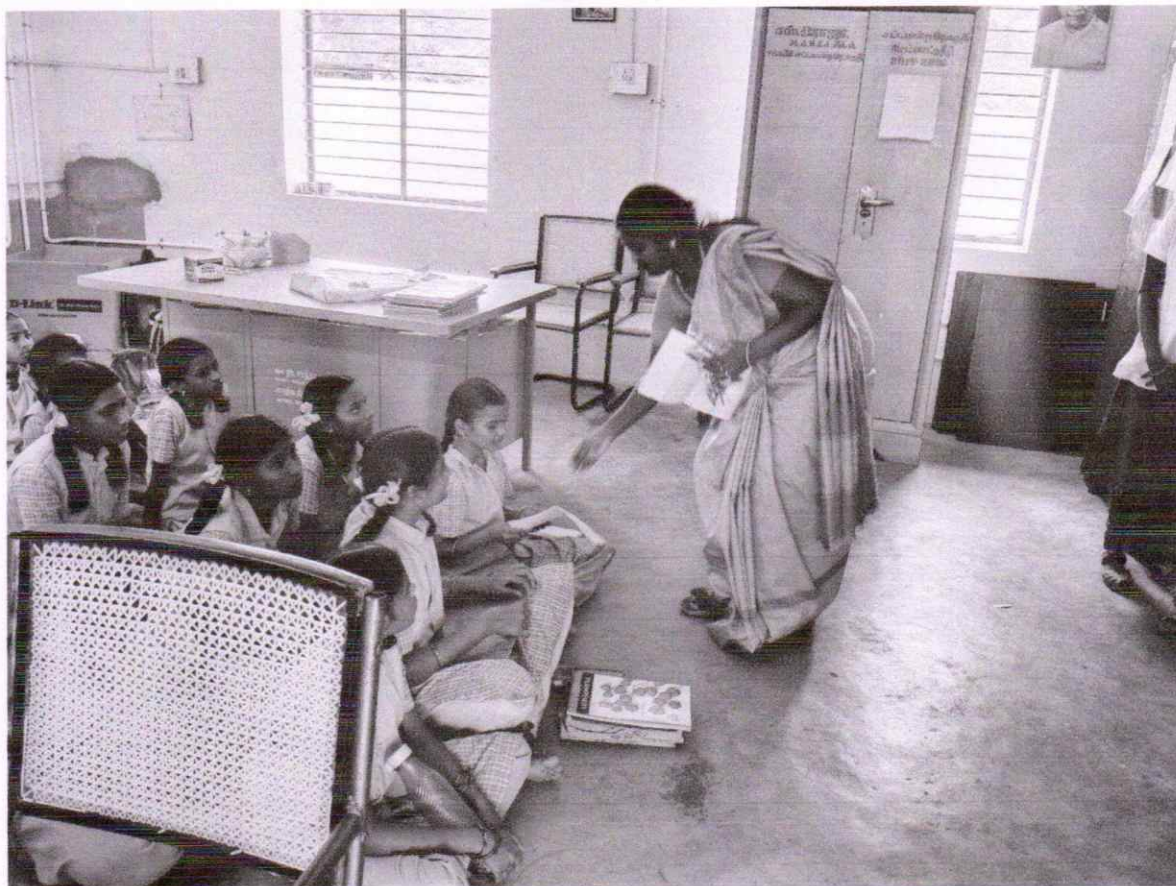

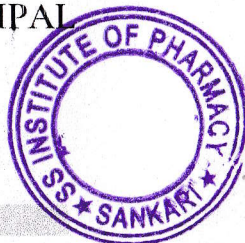
