

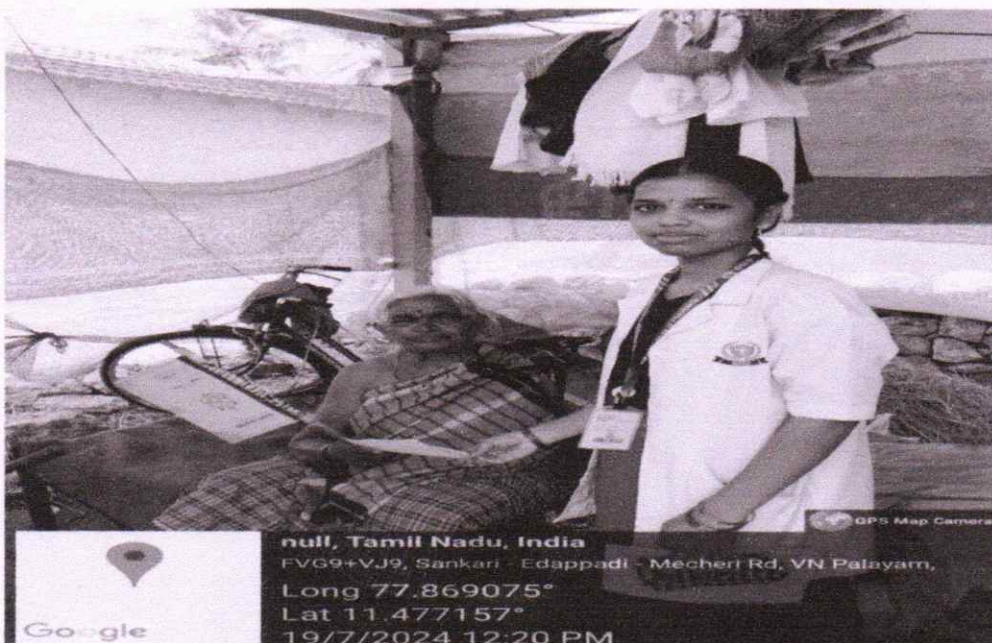

Event Highlights:

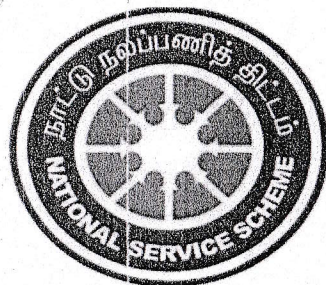
- **Interactive Sessions:** The participants engaged in interactive sessions that highlighted the environmental and health impacts of improper disposal of medicines.

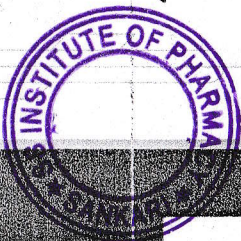



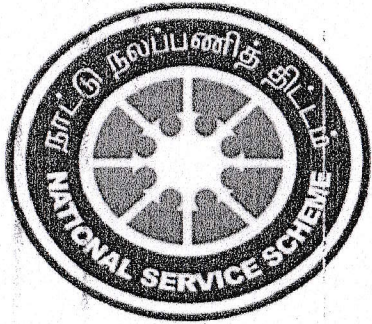
Beneficiaries:
