### MEMORANDUM OF UNDERSTANDING

### 2. General Terms of MOU

- **2.2 Coordination**: In order to carry out and fulfill the aims of this agreement, each party will appoint an appropriate person(s) to represent its organization and to coordinate the implementation of activities Uma clinic and SS Institute of Pharmacy stalls will meet regularly to discuss progress and plan activities.
- **2.3 Confidentiality**: Each party agrees that it shall not, at any time, after executing the activities of this MOU, disclose any information in relation to these activities or the affairs of method of carrying on the activities of the other without consent of

**2.4 Termination of MOU**: The partnership covered by this MOU shall terminate upon completion of the agreed upon period. The agreement may also be terminated with a written one month notice from either side. In the event of non-compliance or breach by one of the parties of the obligations binding upon it, the other party may terminate the agreement with immediate effect.

**2.5 Extension of Agreement**: The MOU may be extended provided the parties agree upon, and can provide the necessary activities.

**2.6 Communications**: All notice, demands and other communication under this agreement in connection herewith shall be written in English language and shall be sent to the last known address, e-mail, or fax of the concerned party. Any note shall be effective from the date on which it reaches the other party.

2.7. Addendum: Any Addendum to this MOU shall be in writing and signed by both parties

# 3. Other Provisions

(1) SS Institute of Pharmacy will provide competent candidates to the Abirami Pharmacy Uma Clinic terms and conditions stipulated in this MOU and subsequent Addendums

(2) SS Institute of Pharmacy shall immediately inform Abirami Pharmacy Uma Clinic of any event, which could have a negative influence on or endanger the successful accomplishment of the tasks described in the agreement.

(3) Both parties agreed to work with each other with mutual consent and according to the plan for their mutual interest. The terms and provisions in this MOU also apply to any subsequent Addendum to this agreement
