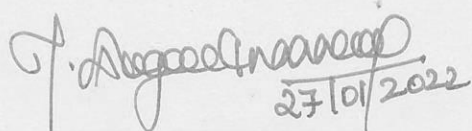

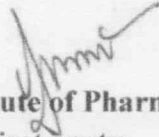

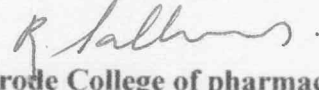

In case of termination, a minimum of a 30 days' notice period is required.

Variations or modifications to this MOU may be proposed at any time by either party and will only be legally binding when agreed in writing by both parties.

5 Governing Laws

This Memorandum of Understanding is governed by and interpreted in accordance with the applicable laws of Ireland.

6 Non-Exclusivity

Participation in this MOU is not exclusive and shall not prevent JKKMMRFs Annai JKK Sampoorani ammal college of pharmacy or SS Institute of Pharmacy College from entering into similar understandings with other institutions.

7 Publicity

JKKMMRFs Annai JKK Sampoorani ammal college of pharmacy and SS Institute of Pharmacy College may make reference to this MOU as a general understanding between the institutions. Details of programme arrangements can only be publicised on completion of the specific Agreements referred to in section 3 v above.
