A campus-to-community rally on “Safe Use of Over-the-Counter Medications” mobilised 118 students and 8 faculty along a two-kilometre route, engaging about 500 local residents through street-corner demonstrations and leaflet distribution. Pre- and post-rally quizzes showed marked learning gains—ability to read drug-facts labels rose from 42 % to 88 %, and awareness of the risks of self-medicating with antibiotics increased from 37 % to 81 %. Seventy-eight percent of participants pledged to check expiry dates routinely, while 64 % committed to keeping a personal medicine list to monitor drug interactions. The local chemists’ association has agreed to display OTC-safety posters for three months, and the Parent–Teacher Association has requested a follow-up session, underscoring the programme’s sustained community impact.
