3. **Distribution of Pamphlets:** A total of 10 pamphlets were distributed, providing valuable information on maintaining good eye health.

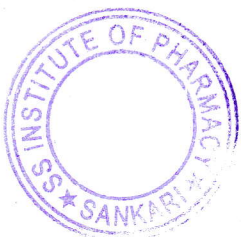
