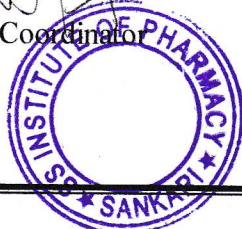
Program Details:



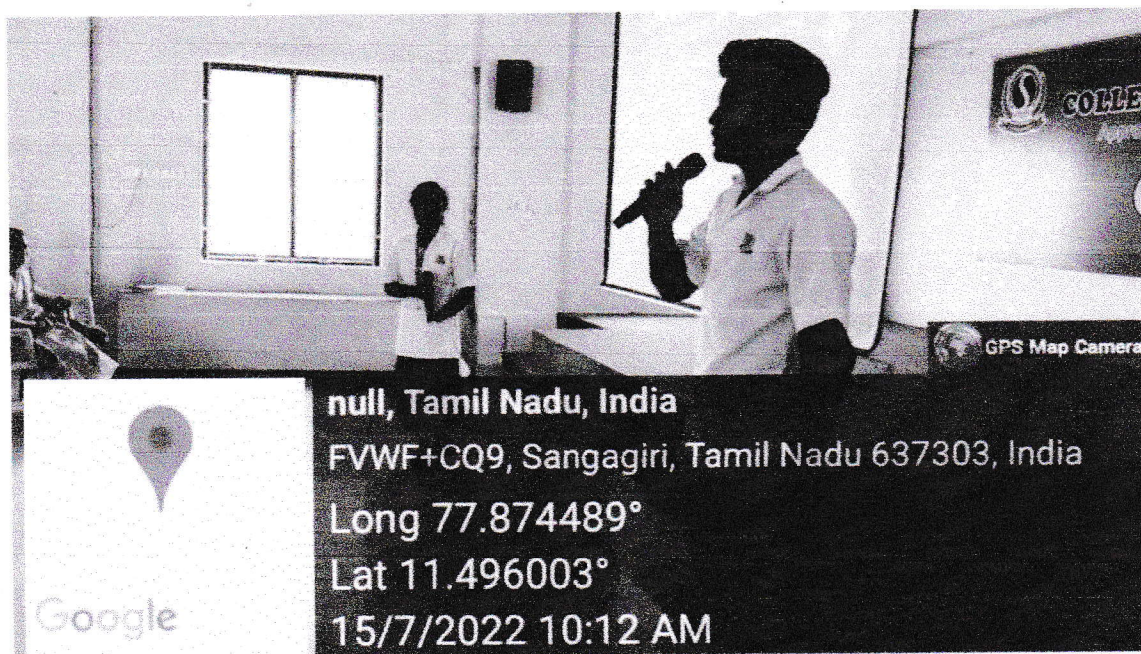

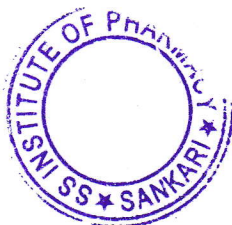
