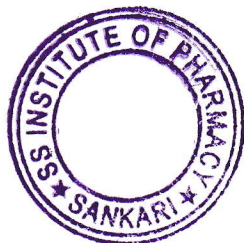

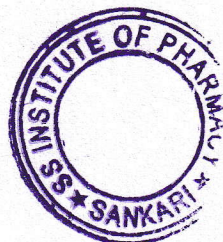

## Summary of the Event

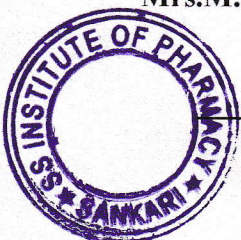

i) Meeting called to order

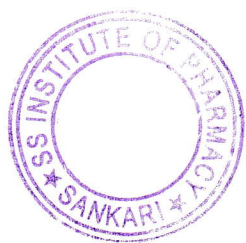
ii) Mrs.M.Vanitha welcomed the faculty & students, members of women empowerment cell. She initiated the meeting and discussed the action plan for this academic year.
